The Brookfield R-III Board of Education, Brookfield, Missouri met in regular session on Tuesday, January 17, 2017, at 5:30 p.m., in the district conference room. All board members were present.

President Vogel called the meeting to order and led everyone in the Pledge of Allegiance. The agenda was approved as presented. There were no public comments. The Consent Agenda items were presented as amended.

Dr. Collins recognized the board and stated that it was Board Recognition Week from January 22 0 28, 2017. He thanked them for their many hours of service and read a proclamation from Governor Nixon regarding Board Recognition Week.
